When heated to decomposition it emits toxic fumes of Hydrogen Chloride, nitrogen oxides, carbon monoxide, carbon dioxide, and nitrogen. As with most organic solids, fire is possible at elevated temperatures

**Special Remarks on Explosion Hazards:**

Fine dust dispersed in air in sufficient concentrations, and in the presences of an ignition source is a potential dust explosion hazard.

## Section 6: Accidental Release Measures

**Small Spill:**

Use appropriate tools to put the spilled solid in a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

### Precautions:
