4 First aid measures

After skin contact: Immediately wash with water and soap and rinse thoroughly for at least 15 minutes.

After eye contact: Rinse opened eye for at least 15 minutes under running water. Then consult a doctor.

· **Information for safe handling:**

Ensure good ventilation/exhaustion at the workplace.

Open and handle cylinder with care.

Handle with care. Avoid jolting, friction, and impact.

Use only in well ventilated areas.

Store cylinders upright with valve protection cap in place and firmly secured to prevent falling or being knocked over.

If difficulty with operating cylinder valve is experienced discontinue use and contact supplier.

· **Information about protection against explosions and fires:**

Keep ignition sources away - Do not smoke.

Protect against electrostatic charges.

Pressurized container: protect from sunlight and do not expose to temperatures exceeding 50°C. Do not pierce or burn, even after use.
